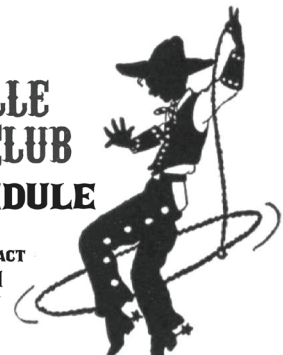


BRUC Board Meeting Minutes Feb 4, 2010
